


# For graduate, business and law school. For your future.



### lt's a smart move

### How to get started

If it has been a while since you have been in school, that's okay. Here are some tips to help you get started.

First, you will want to think about the type of school and program that will be the best fit for you.

You will also want to take the *GRE®* General Test — it is the test that graduate, business and law schools around the world use as part of their application process. Plus, the *GRE®* Program has a variety of **free resources to help you get ready!** 

Here are some **quick facts** about the GRE General Test:

- The content of the test closely reflects the kind of thinking you will do in graduate school.
- The test takes about 3 hours and 45 minutes (plus timed breaks) and you will take it on computer at an official test center, or the test can be taken at home.
- The test covers:

**Verbal Reasoning** — Measures your ability to analyze and evaluate written material and synthesize information obtained from it, analyze relationships among component parts of sentences and recognize relationships among words and concepts.

**Quantitative Reasoning** — Measures problem-solving ability, focusing on basic concepts of arithmetic, algebra, geometry and data analysis.

**Analytical Writing** — Measures critical thinking and analytical writing skills, specifically your ability to articulate and support complex ideas clearly and effectively.



### **Refresh your skills**

If it has been a while since you have encountered questions on these topics, the GRE Program has a number of free test preparation materials that can help you refresh your skills. Two of the documents you might find useful are:



#### GRE Math Review

This 100-page math refresher includes definitions, properties, examples and a set of exercises with answers at the end of each section to assist you in preparing for the GRE General Test.



#### GRE Math Conventions

Mathematical notations, symbols, terminology and guidelines are included for interpreting information in the GRE General Test.
